This is to address my son Justin and his behavior. In the start of his overnight stays the foster parents have not sent Justin with any of his medication his hyper activity medication or his sleeping aid. In the time that we have had Justin over the weekends the foster placement has only sent his medications for 3 weekend visits but they only sent enough of his medication for 2 of the 4 days that he spends with us. In the beginning there was a general stiffness to Justin as we have spent time he has explained that he does not get to go out and play he is not allowed to play with the kids in his neighborhood. He explained to me that he does not have time to play with all his chores he has to do. He likes reading his books because he gets in trouble less at the foster placement. I have seen him playing with the kids and his behavior in my observations I understand that Justin's social skills are rough in the sense that he clearly does not have much interaction with peers in a play setting and what experience he does have he has developed a fairly sarcastic demeanor. We have had discussions about how his social skills need work and as things come up we work through them. In the time that we have had I have seen great improvement in his behavior both with the neighborhood kids and his brother and sisters. The CPS case was dropped and is closed we agreed and developed a safety plan with cps seeing as how Jessica smith never tried to develop a safety plan. Justin's truancy from school is not caused by Eric the foster placement has Justin in their custody on the days that he is reported absent. Justin has told us that the Hobans keep him home from school

because he is too tired and or out of control. That is not an excusable reason even by the school's standards. Justin has never been out of control when he is with us and we return him to the foster placement by a reasonable hour well rested, he gets sleep at our house we consulted a pharmacist and were suggested to give Justin melatonin. Even after the Hobans have been ordered to have no contact they are now giving their false slandering reports to Jessica smith and she is delivering the reports to the therapist. This brings me to my next point everyone needs to approach and reinforce with Justin threw this transition positively. Many times Justin has made comments that are questionable to me things like he does not know who to trust or Shanna and I hate each other or the Hobans have told Justin that we are trying to kill him by giving him a natural sleep aid he has been instructed to not wear the clothing we have for him here, that he is not native he is a descendent of European king. When Justin was here last weekend and at a therapy session Justin said that he has made up his mind about where he wants to live, that he is ready to move home with me he said that he was going to tell the judge his decision. Justin has been told by the hobans and Dr. Jensen that Justin is not allowed to discuss any of the therapy or evaluations with anyone but the hobans. Again the order of the hobans to stop swaying the therapist with their false reports is being trampled on and ignored. Why did Justin have to be subjected to another psycho-sexual evaluation with Dr. Jensen he has had all these evaluations done repetitively. All of which was based from unfounded information it started with Marry Hoppa ,Dr. Jensen, now mark gray and more proof of tony fosters involvement. This should be considered abuse to Justin making him undergo all these examinations and investigations. They are setting the stage to say they made reunification efforts but Justin acts out because of his visits. But Justin is only acting out when in the foster parents care; if he is acting out at all. In the report given by mark gray has captioned the fact that tony foster was the direct recipient of the report as shown in the CC field of the email. This is a breach of confidential information why is tony foster getting medical reports of my son. It appears that tony

foster is leading the therapist why else would the contact be direct where he should have no involvement in a case that he is not a party too. This is abuse of power. When Justin is in my care he was never out of control or demonstrated any sexualized behavior or anything the fosters are claiming. The court is trying to fallow the recommendations of the therapist when the therapist is working with false information that is provided from the Hobans threw Jessica smith. It seems that the para educator judging from her reports has been given false information also. Justin needs to be protected from this foster placement he is afraid of them and it has been confirmed by this court. Yet you make him stay in a prison setting. ICW never truly tried to reunify they continue let the foster parents manipulate the therapist; ICW reinforces false concerns and continue to ignore the orders of this court and its laws. ICW is stacking the deck by copy and pasting past reports to current reports to make things seem to be the same. When I asked Justin if what Jessica and the gal have said is the correct version of his feelings and what he has said and he told me no. but Jessica and Astrid have twisted what I have said too. When I said that I won't stop Shanna from seeing Justin Astrid said that I won't stop her from seeing Justin because of where I live. It is what this court has done the whole case history twist and convoluted until they achieve what the tribe wants. This whole case only goes to prove the extent the tribe "tony Foster" will go to in an attempt to steal my children. They have slandered my wife Shanna then myself after they can't prove their slander now they turn to slander my son calling him a sexual predator (same as they did to us) to justify why not to return my children. The court has called myself, Shanna, and now my son sexual predators to gain unlawful custody of my daughter. They have destroyed my family so they can steal my daughter and now this court seeks to do the same to my son. Buy not using and or following any law's this court has failed with all do respect this family my family. Please respect our family and return my children. One of the last reports that Jensen gave he tried to explaining that he was only basing his reports from Marry Hoppa's recommendations. Seeing as how Marry Hoppa was removed

from this case due to her unethical conduct his opinion is tainted and should not be admitted just the same. It has been outlined already that when they get the report from Jensen they are going to change the court order of visitation accordingly. They have gotten into the habit of copy and paste now they are heading down the same path with my son as they have with my daughter in saying that a sheared custody order might be the best plan for Justin. I will not let this happen my son needs to be removed from this foster placement and returned to me immediately under rcw 13.38.130 and rcw 13.38.150 I have never been proven unfit I am able to provide for him he is not in any harm and I have removed my consent to foster placement many times in this m.i.n.o.c case. Where is Rachel Hardies full report I was never given her report I want to know what else she wrote. I am sure that there was some positive things mentioned and that is why I was not given a copy. The only good reports about Justin in the court records is during the time he was in my care his IEP and CPT reports were improving so greatly the staff were amazed. Then the court took him from my care. Since then the tribe and foster placement have only ever reported negatively about Justin.

The contact that Shanna has had with Justin has been short and has never put Justin in harms way I feel to cut off this contact would only cause him pain Justin has said many times that he liked seeing his mom he was glad that he got to spend some time with her. It was only on Shanna's birthday 2-19-16 that when Shanna came by to say hi and see Justin that he greeted her with your not allowed to be here the Hobans said that your not supposed to be here that your a danger to me. When I tried to speak with Justin about what he said Justin went on further to say that everyone got a copy of the court order that Shanna, Sam, and Clark are not to see Justin. There is no order against Sam and Clark his grandparents calling for no contact. The foster placement of Sammy has been letting Shanna see Sammy over the past 5 years why should Shanna not have contact with Justin. When I brought this to the attention of the GAL she explained that it is ok because the fosters are the guardian of Sammy. I pointed out

how do the guardians for the past year have more authority over my children then myself the biological father of my children? Jessica smith goes on to say that that she can not get a hold of Shanna but Jessica smith and Shanna are friends on Facebook Jessica has not tried to contact Shanna. Shanna just saw Jessica 2 weeks ago at subway but she never said that she was trying to get a hold of her. I myself have told ICW and the GAL that Shanna lives 2 doors down. They have never come to try to talk to her at her house.

In no way am I trying to prevent Shanna from seeing either of our children this court needs to understand the laws of human nature the need to have a relationship with a

needs to understand the laws of human nature the need to have a relationship with a mother and father now Justin is ready to move into that setting where he can build this relationship with both entity s in a safe environment let him have this relationship to grow and learn from as families do. The mind set of keeping the family apart is what got this case to where it is today to continue this destructive path will only perpetuate the very concern (the only concern) this court has Justin's emotional state. His emotional state is caused by the time he has been kept away from his family. I would like to recommend to the court to allow for Justin to be allowed to come home permanently. In order for Justin to heal adjust and progress at a natural state threw the positive reinforcement, unconditional love, and constancy that he has found here in our home. He has expressed to me and family therapist Rachel Hardies his desire to spend more time with me, his mom, and his family. Allow Justin to come home and continue building his relationship and feel the security of establishing his place in the family. Culturally speaking according to the ICW act we all know what needs to be done. Let this family heal.
